

PUBLIC NOTICE OF PROPOSED CHANGES TO THE RULES, REGULATIONS AND FEE SCHEDULE OF THE WYOMING WORKERS' COMPENSATION DIVISION

PUBLIC NOTICE IS HEREBY GIVEN that the Wyoming Workers' Compensation Division is proposing changes that will affect the Division's rules, regulations and fee schedule. These proposals include modifications to the *Wyoming Workers' Compensation Rules, Regulations and Fee Schedules*;

The Department proposes minor grammatical and formatting changes as well as the following specific changes to Chapter 1 – General Provisions:

Chapter 1, Section 3 – Definitions:

- (a) updated the effective date for CFR from October 1, 2004 to January 1, 2018
- (j) Added details to clarify the Clerical Office Occupations definition, including how this classification can be revoked
- (k) Chiropractic Utilization Guidelines – updated effective date from 11/21/13 to 3/1/18
- (p)(i)(iii)(iv) Corporate Officers and Members of Limited Liability Companies – added Partners and Sole Proprietors – deleted WSCD and replaced with Wyoming Workers' Compensation Division or the Division.
- (y) Fixed Base of Operations - updated “an” to “nn”
- (aa) Hearing Examiner or Officer – updated website address for Wyoming Uniform Rules for contested Case Practice and Procedure, Chapter 2, Section (e)
- (bb) Inside Sales Occupation Classification - added (ii) on how the inside sales occupation classification can be revoked.
- (ff) Medical Service – deleted “drugs” and added “prescription” medicine
- (kk) Outside Sales Occupation Classification - added (iii) on how the outside sales occupation classification can be revoked.
- (mm) Primary Treating Health Care Provider - added her or his/her
- (oo)(ii) – Experience Rating – clarified the definition of experience rating and added the experience rating is based upon frequency and severity of injuries reported to the Division.
- (rr) Remuneration. Changed Accountability to Accountable Plan; and, Chapter 2, Section 15 to Section 14
